ROOF TOP SOLAR: WORLD BANK SCHEME- KEY HIGHLIGHTS

Parameters	Description
Purpose	To part finance setting up of Grid Connected Rooftop Solar Power Project under World Bank Scheme.
Target Group	All Industrial Units, Commercial Institutions such as Hotels, Shopping Malls, Hospitals, Petrol pumps, Schools / Colleges owned by the Borrower.
Facility	Term Loan & Working Capital
Loan Amount	Maximum Rs.50 crores (in R&DB Branches)
Interest Rate	Pricing linked to Internal Rating: Starting from 8.75% onwards (based on Current EBLR)
Margin	Term loan Upto : 30% of Project Cost.
Debt : Equity	Max : 70: 30.
Repayment	Term Loan: In 15 years including a moratorium. The overall door to door tenor (repayment + moratorium) not to exceed tenor of offtake Agreement.
Moratorium	Construction Period / Achievement of COD 6 months. Moratorium After COD : 6 months. Interest to be serviced during Moratorium.
Other conditions	• Commercial Industrial Building Should be owned / if leased should be in possession of borrower •DSRA equivalent to 3 months Principal & Interest.

Interest Rate	Pricing linked to Internal Rating: Starting from 8.05% onwards (EBLR + 0.50%) (existing SME Connections). New to Bank Connections : Starting from 8.30% onwards (EBLR + 0.75%)
Margin	Term loan Upto: 20% of Project Cost.
Debt : Equity	Max 80:20
Repayment	Term Loan: In 10 years including a moratorium.
Moratorium	Construction Period / Achievement of COD 6 months. Interest to be serviced during Moratorium.
